For value received, I agree on behalf of myself, my child's other parent if known or living, my child named herein, and our heirs, successors, and assigns ("Our Behalf") that I assume all risks and waive any liability of any nature whatsoever against and agree to hold harmless Retreat Center, et al., Sponsor, et al., and the Chaperons et al. with respect to any and all actions, claims or demands that may be made or brought on our Behalf against Retreat Center, et al., Sponsor, et al., and/or the Chaperons et al. arising out of or in connection with my child's travel to or attendance at the camp, or any other activity my child may engage in while in transport there. **The Activity participants agree to the following:**

- Project an image of consideration, sensitivity, and respect to everyone and to the property around them through language, dress, and behavior
- Refrain from inappropriate touching, fighting, and verbal harassment
- Respect other persons and/or property
- Refrain from actions that could result in injury and/or damage to property
- Adhere to stated curfew
- Attend all scheduled activities, arriving promptly, and staying for the entire event
- Report problems of any kind to a trusted adult member of the retreat team
- Travel in groups of three, avoiding situations where they are alone with other Staff and adults
- Always tell an adult leader where they are going to if they leave the main event area.

**The Activity participants agree not to:**

- Possess weapons or fireworks of any kind
- Purchase, possess, consume, or distribute alcohol
- Purchase, possess, consume, or distribute illegal drugs or tobacco products
- Engage in any form of sexual activity or Youth sexual harassment
- Use profanity, degrading language of any kind, or participate in Bullying
- Visit or gather in sleeping areas of the opposite gender

**Dress Code:**

In keeping with the nature of **Dharma Healing & Wellness, LLC. (Little Girl Grown Woman Issues and Up With the Best of Them)** events, all participants are to dress in a modest fashion. This includes the following:

- Shorts and Skirts will not be more than 5" above the knee when standing.
- No sleeveless, cut off or midriff tops are allowed. All tops will have sleeves and either crew or polo styles. No strap tops allowed. No scoop neck styles allowed. Shirts and Blouses must be worn in an appropriate manner.
- Undergarments must not be visible at any time • No yoga pants, leggings or similar types of clothing without a long shirt fully covering the buttocks.
- No offensive or inappropriate language on clothing, no language or symbols of any kind on rear of shorts, pants, etc.
